## Who are ASK Friends?

All Saints Kenton Friends (ASK Friends) is a community organisation which formed in September 2020 to support the conservation, maintenance, and improvement of the fabric and fittings of All Saints

Church.

## **The Background**

Kenton church was closed to the public in October 2019 due to fallen plaster from the south aisle ceiling. The north aisle ceiling also had cracks which needed repairing to make the church safe at a cost of around £50,000. At that time, there were insufficient plans to repair and re-open the church.

A village meeting was held about the future of the church, and ASK Friends was formed. The community made significant donations to enable repairs both to the South and North aisle ceilings and roof. The church re-opened for Easter Sunday 2021.

## **The Two Aspects to the Life of the Church**

1) The spiritual life of the church is currently overseen by Reverend John Williams, based in Exminster. The congregation is small. A minister appointed in December 2021 resigned at the end of February 2023 and All Saints is hoping for the appointment of a new minister.

2) The building itself: the church is a large grade 1 listed building which requires a huge amount of money to maintain.

## **Who pays for the building maintenance?**

The church building is owned by the C of E, but the maintenance of the building is the responsibility of the PCC (Parochial Church Council) who are considered stewards. To merit a resident minister, the congregation of Kenton has to contribute to the diocese “Common Fund” – around £14,000 annually, plus major costs for insurance and energy.

When ASK Friends formed in 2020, the financial burden had become too great for the small congregation and there was a real risk that without support, the church would fall into disrepair and close for ever. During Covid 19, the situation became compounded as the church was unable to hold services or fundraise.

## **Why was ASK Friends Formed?**

In September 2020, ASK Friends was formed to spearhead a campaign to save the church. Many people in Kenton care deeply about the church building which has stood for centuries at the very heart of our village. Of great architectural interest and visited by people from all over the world, it represents our heritage. Regardless of religious belief,

we need to preserve it for generations to come. ASK Friends is not a religious group.

### **Who are the trustees?**

The three trustees are a mixture of people of faith, no faith and those in between. We share a love of the building and its place in our local community: Jane Perkins (Chair), Robert Rand (Vice-Chair), Anne Hatcher (Treasurer). We have one co-opted committee member, Mandy Hendley.

### **What is ASK Friends Trying to Do?**

Initially, our aim was to support the PCC to raise funds to repair the building so that the church could reopen. We are now working with the PCC to prioritise the maintenance work for the church building. We would also like to develop it as a community space for a whole variety of activities and events, in addition to Sunday worship.

### **Can Anyone Join Ask Friends?**

We want as many people in the village as possible to get involved - please join us! We now have charity (CIO) status which means that Gift Aid can be claimed on donations. Fill in the form at the end of this leaflet or join via our website. £5.00 (individual) or £10 (household) per year, payable in May.

### **How Will We Raise the Money?**

One of our sources of funding will be through grant applications. However, money is also raised through various fundraising activities within the church (eg quizzes, art talks, concerts) and we will of course welcome donations, no matter how small.
